The Human Genome Project had not yet begun, and most human subjects research took place in North America and Europe. No World Wide Web or open access journals existed. All that has changed. As part of the new wave, Dove Press is launching a new journal, *Medicolegal and Bioethics* as an online, open-access, peer-reviewed, interdisciplinary and international journal we aim to meet rigorous intellectual standards, yet deliver content rapidly.
