Norwegian nurses' attitudes towards assisted dying: A cross-sectional study

Definitions on assisted dying and questionnaire translated from Norwegian to English.

A Dutch definition in an edited form is applied on assisted dying:

Euthanasia is defined as an act with a physician intentionally killing a person by injecting drugs, at that person's voluntary and competent request. *Physician-assisted suicide* is conducted by a physician who intentionally helps a person to commit suicide by providing drugs for self-administration, at that person's voluntary and competent request. (Griffiths J, Weyers H, Adams M, editors. Euthanasia and Law in Europe. Oxford: Hart Publishing: 2008). These definitions are used in NOBAS (Magelssen et al. 2015)

Example on euthanasia: to inject a lethal injection on the patient's incitement. Example on physician-assisted suicide: facilitating medication so that the patient can swallow or inject the medication himself.

Questions 1-8: Norwegian Bioethics Attitude Survey (NOBAS) (Magelssen et al. 2015). Questions 9-15: added in this study.
